Adriana di Salaparuta. Name and device. Azure, a dragon and on a chief Or three bunches of grapes purpure.

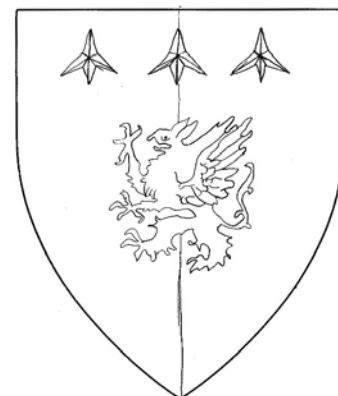


Afshin Darius. Name.

Brian de Lorne. Name and device. Per pale sable and azure, a griffin and in chief three caltrops Or.

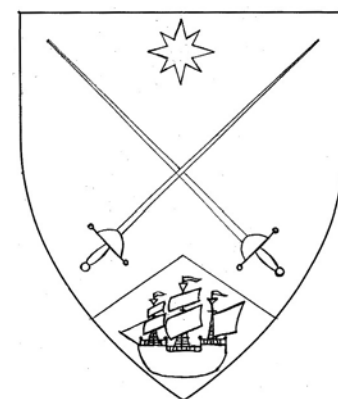


Catherine Lapyn. Name.

Eirín inghean Dubhghaill. Name. In registering the name, the Laurel staff modified the final element to change the initial “Dh” to plain “D” because they felt it was more period.

Esa Kirkepatrike. Name.

Geoffrey Clwyd. Name and device. Azure, two rapiers in saltire and in chief a mullet of eight points Or, on a point pointed argent a ship in full sail sable.

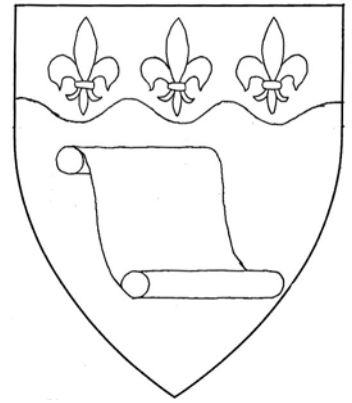

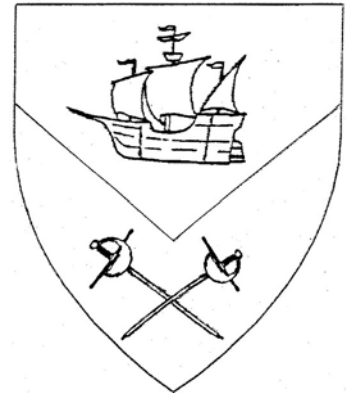
Héloïse Le Gardeur. Name and device. Purpure, an open scroll bendwise and on a chief wavy argent three fleurs-de-lys azure.

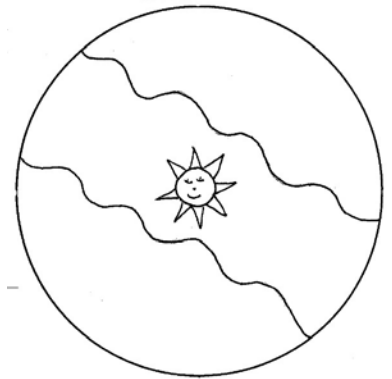

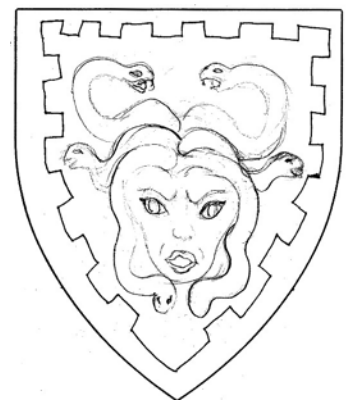
Juan Carlos Castillo de Coronado. Device. Per chevron inverted argent and azure, a ship in full sail sable and two rapiers inverted in saltire argent.



Katharine de la Vache. Badge. Or, on a bend wavy azure a sun in splendor Or. This should technically conflict with Madelena Palmieri (“Or, on a bend nebuly azure a feather argent.”) since by precedent there is no difference between an ordinary nebuly and one wavy. However, since her device (“Or, on a bend wavy azure three suns in splendour Or.”) was registered without comment in April, 2005, the Laurel Office has ruled that this badge is “grandfathered” against conflicts with Madelena since the conflict was missed at the time the device was registered.

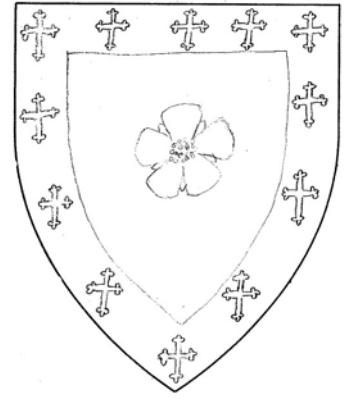


Lucius Aurelius Valharic. Name and device. Sable, a gorgon’s face within a bordure embattled Or.



Marlein Magdalena Weber von Rothenburg. Device. Azure, a rose argent within a bordure argent crusilly bottony sable. In registering this, the Laurel Office asked that the rose be drawn larger.

Nimenefeld, Canton of. Device. Gules, a garb within a laurel wreath and on a chief Or, a demi-sun gules.

Olivier de Bayonne. Name.

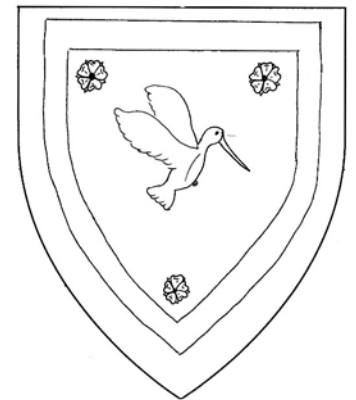
