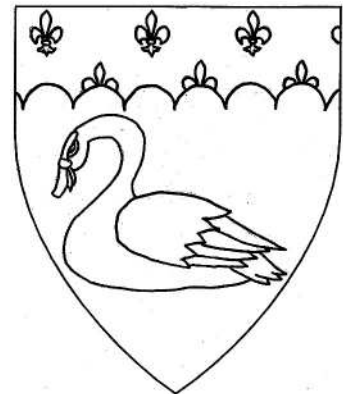
Unto the populace of Atlantia, greetings from Alisoun MacCoul of Elphane, Golden Dolphin Herald!

Herein you will find the results of the deliberations of the College of Heraldry of Atlantia during the month of March, 2010.

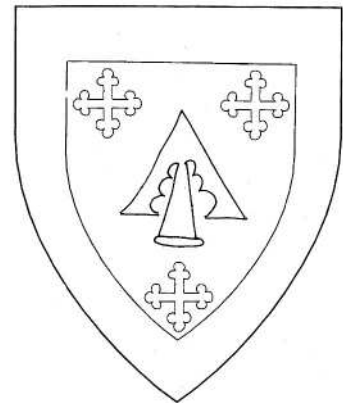
## ACCEPTANCES

The following submissions have been accepted and included on a Letter of Intent to the College of Arms from Atlantia dated 31 March, 2010:

**Aldis Svansdottir.** Device. Gules, a swan naiant argent and a chief engrailed argent semy-de-lys sable.

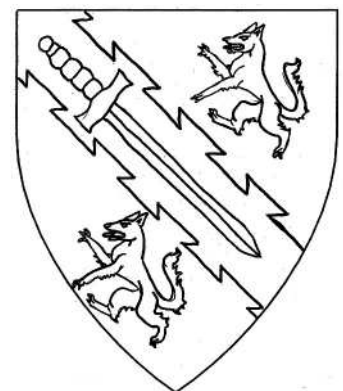


**Apollinaris Salvi da Pisa.** Device. Vert, a pheon inverted argent between three crosses bottony within a bordure Or. An identical device submission was pended for redrawing by Golden Dolphin in February, 2010.



**Asta knarrarbringa.** Name.

**Brandr feilan inn kyrri.** Name and device. Argent, on a bend dovetailed sable between two wolves rampant gules a sword inverted argent.

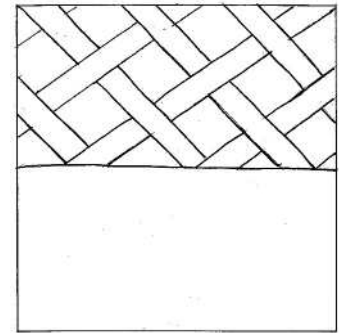


**Caitilin MacDonoghue.** Device. Per pale azure and gules, a unicorn Or within a bordure erminois. This submission was pended by Golden Dolphin for redrawing in February, 2010.



**Catguistl of Tintagol.** Name (see RETURNS for device). We modified the name from the submitted Catguistl of Tyntagell as the only period documentation we found for that spelling of the place name dated to the reign of Henry VIII, some six centuries after the date for the given name and precedents that have ruled similarly dated given names to be a step from period practice when used with later English forms would almost certainly have added a second step from period practice prompting a return.

**Cecilia Blythe.** Badge. Per fess Or fretty azure and azure.

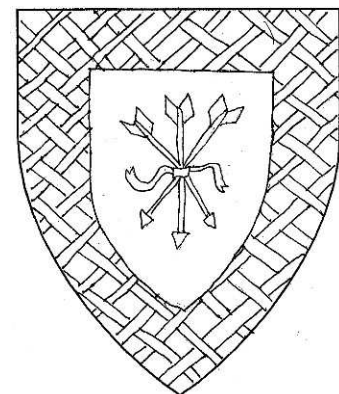


**Clare Dupré.** Name (see RETURNS for device).

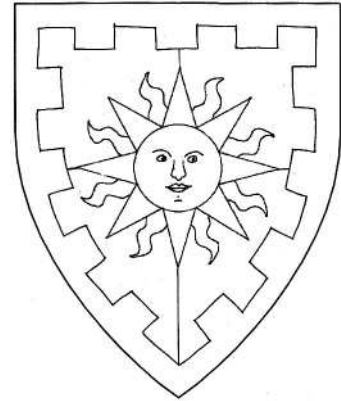
**Dunstan le Heryngmongere.** Household name and badge for House Thistle and Herring. (Fieldless) A thistle slipped bendwise sinister proper sustained in the mouth of a herring hauriant embowed Or.



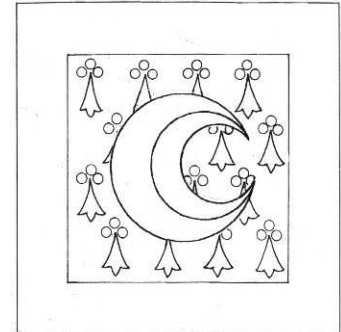
**Eleanor de Chester.** Device. Argent, a sheaf of three arrows proper fletched sable banded vert within a bordure vert fretty Or.



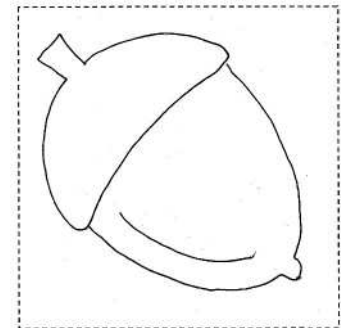
**Emelina atte Avon.** Device. Quarterly azure and gules, a sun in splendor Or within a bordure embattled argent. An identical device submission was pended for redrawing by Golden Dolphin in February, 2010.



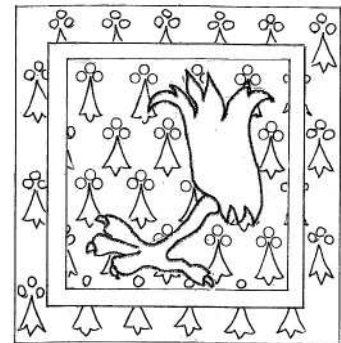
**Hawkwood, Barony of.** Order name and badge for the Award of the Golden Decrescent. Counterermine, a decrescent Or within a bordure argent.



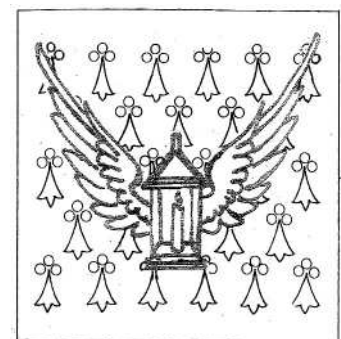
**Hawkwood, Barony of.** Order name and badge for the Award of the Green Acorn. (Fieldless) An acorn bendwise vert.



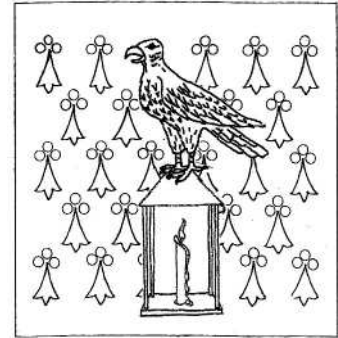
**Hawkwood, Barony of.** Badge for the Award of the Silver Jess. Counterermine, a hawk's leg erased within an orle argent.



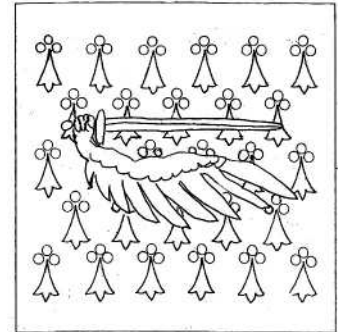
**Hawkwood, Barony of.** Badge for the Award of the Silver Wings of Hawkwood. Counterermine, a winged lantern argent.



**Hawkwood, Barony of.** Badge for the Order of the Silver Hawk. Counterermine, a hawk close argent perched atop a lantern Or.



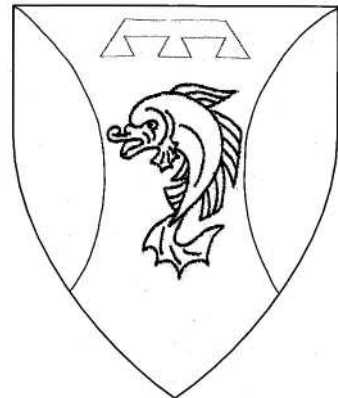
**Hawkwood, Barony of.** Badge for the Order of the Goshawk of Hawkwood. Counterermine, a wing fesswise terminating in a hand sustaining a sword fesswise reversed argent.



**Iain mac Donnchaidh.** Name (see RETURNS for device). Note that the submitter's legal given name is *Iain*.

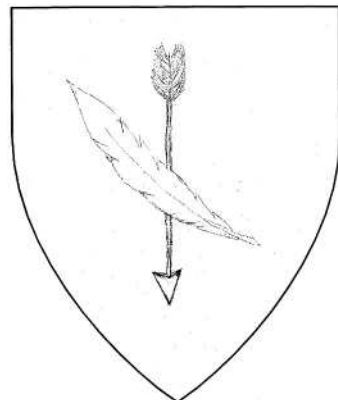
**Ívarr inn svartí.** Name.

**James Easton.** Name and device. Gules, a dolphin hauriant between flanches in chief a label coupé argent. He has a Letter of Permission to Conflict from his real world father Geoffrey Athos von Ulm whose arms ("Gules, a dolphin hauriant between flanches argent.") were registered through Atlantia in February, 2004.

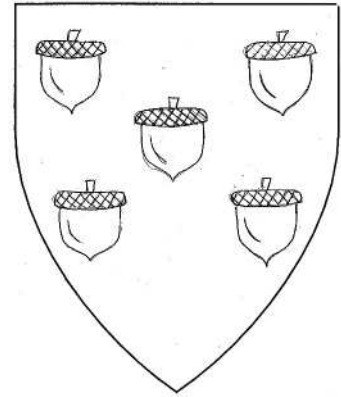


**Jamila bat Hayyīm.** Name (see PENDS for device).

**Katherine d'Orleans.** Name and device. Azure, an arrow Or overall a feather bendwise argent.

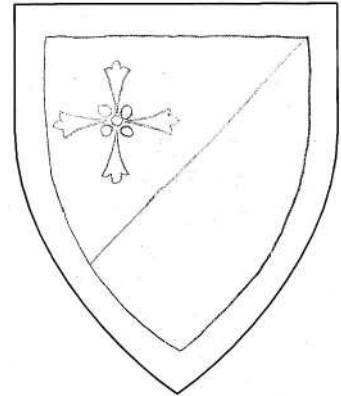


**Maddalena Valeta.** Name and device. Sable, in saltire five acorns Or.



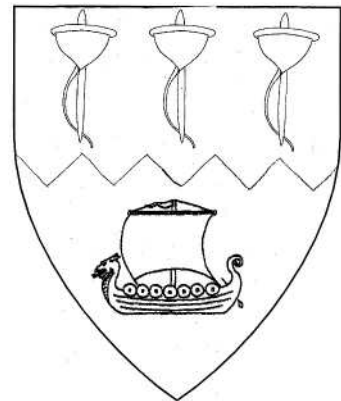
**Maddoc MacRoyri.** Name.

**Mariana Francisco.** Change of device. Per bend sinister azure and gules, in dexter canton a cross of four ermine spots argent within a bordure Or.



**Niese Keppel.** Name (see RETURNS for device). *Keppel* is the submitter's legal surname.

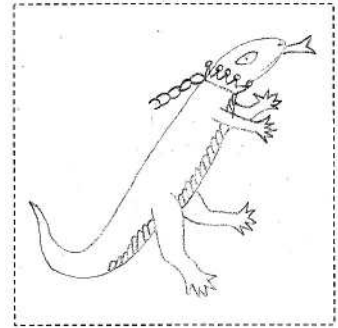
**Oddný knarrarbringa.** Name and device. Per fess indented gules and vert, three drop spindles inverted and a drakkar argent.



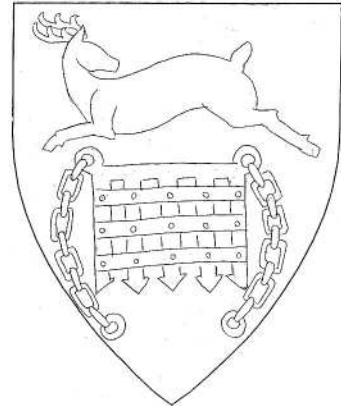
**Øpi Váli.** Badge. (Fieldless) A passion nail argent winged sable. An identically blazoned badge was pended by Golden Dolphin for redrawing in February, 2010.



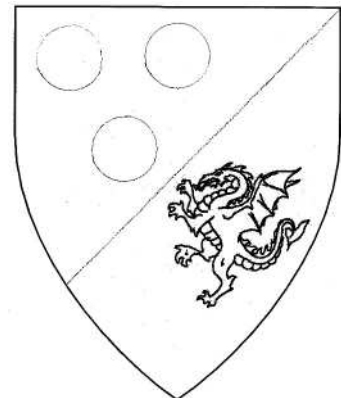
**Oriana of Xylina.** Badge. (Fieldless) A lizard rampant to sinister sable, chained and collared of a pearled coronet Or. The submitter was made a Court Baroness of Atlantia at Tir-y-Don Baronial Birthday and Investiture on 29 March, 2003.



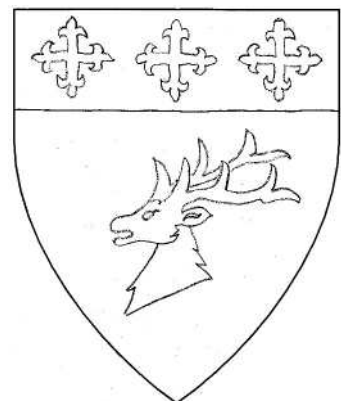
**Petronella Lockeheart.** Name and device. Purpure, in pale a hart courant reguardant and a portcullis Or.



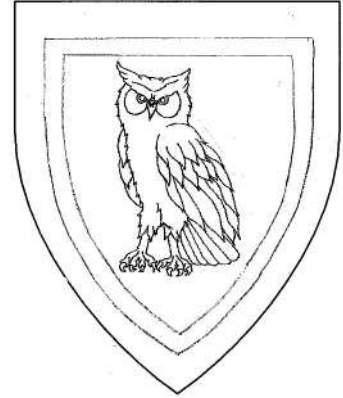
**Philip Jeger.** Name and device. Per bend sinister sable and vert, three plates two and one and a dragon argent.



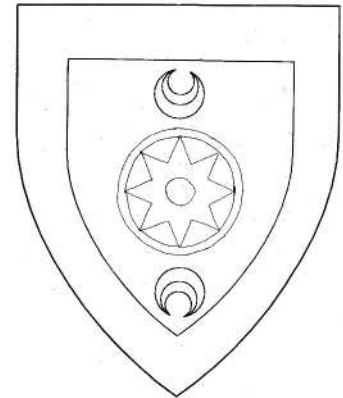
**Richard Montbard.** Name and device. Vert, a stag's head coupé and on a chief argent three crosses flory gules.



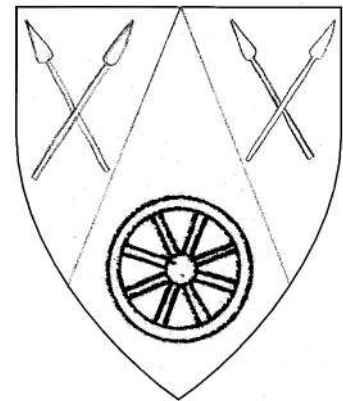
**Roana verch Cadugan ap Reis.** Name and device. Purpure, an owl within an orle argent.



**Sean Mac Griogair.** Change of device. Sable, a mullet of eight points pierced within and conjoined to an annulet between in pale a crescent and a crescent pendant within a bordure Or.

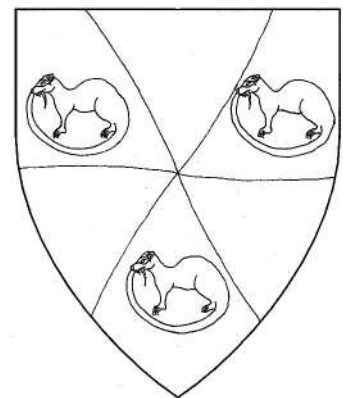


**Stephen le Freman.** Device. Per chevron throughout azure and argent, two pairs of spears crossed in saltire argent and a wagon wheel sable.



**Tancred of Messina.** Name (see RETURNS for device).

**Tómas Tryggvason.** Device. Gyronny arrondy of six azure and argent, three ferrets statant each biting its tail argent.

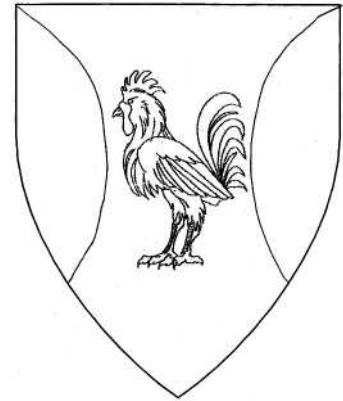


**Porgautr inn vikverski.** Name (see RETURNS for device).

**Vincent d'Orleans.** Name (see RETURNS for device).

**Wenlyan Goch.** Device. Gules, a cock between flaunches argent. An identically blazoned device was pended by Golden Dolphin for redrawing in February, 2008.

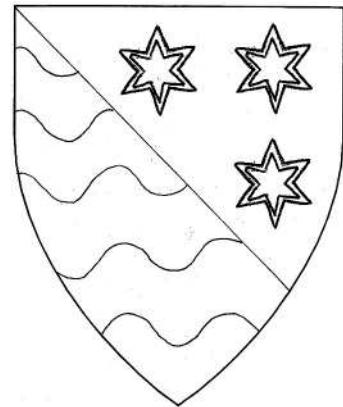

## RETURNS

The following items have been returned for further work:

**Catguistl of Tintagol.** Device. Per bend purple and barry wavy argent and purple, three mullets of six points voided argent. Several commenters noted the restriction of voided and fimbriated charges to simple geometric charges in the center of the field. While mullets of six points have been ruled simple enough to void or fimbriate, precedent is a bit mixed on whether charges placed in the position these mullets hold are central enough to meet the requirements of centrality. There is a good case that the two mullets in bend would meet the centrality test, but that in sinister canton almost certainly does not.

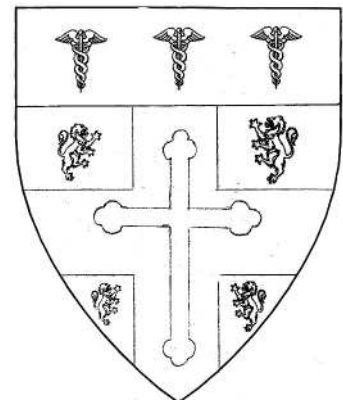


**Clare Dupré.** Device. Vert, a winged wolf sejant ululant Or. Unfortunately, this must be returned for conflict with the badge of Elspeth Turnbull (“(Fieldless) A winged talbot sejant Or.”),



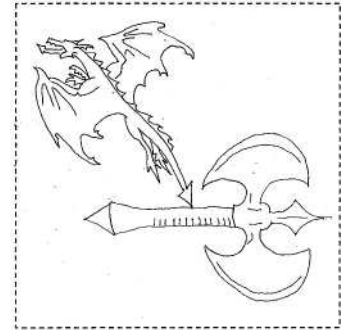
**Duncan MacEwen.** Name. Unfortunately, this name must be returned for conflict with the registered name of Duncan MacEwan.

**Iain mac Donnchaidh.** Device. Argent, on a cross between two pairs of lions combatant gules, a cross bottony Or, on a chief azure three caducei argent. It was the consensus of the commenting heralds that the design was overly complex and must be returned for simplification.

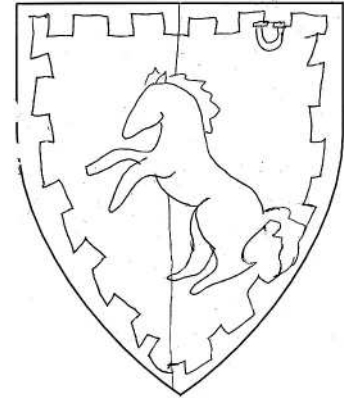




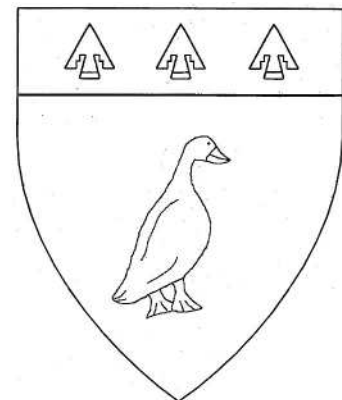
**Ivarr Thorgissson.** Badge. (Fieldless) In bend a dragon volant bendwise gules and a double-bitted axe fesswise reversed sable. The Society requires that charges in fieldless badges must be conjoined. As shown on the emblazon sheet, the dragon and the axe are only notionally conjoined, with a single point of tangency that is equivalent to only one pixel in an enlarged scan of the line drawing. Were the dragon's tail elongated and wrapped around the haft of the axe this would not be a problem.



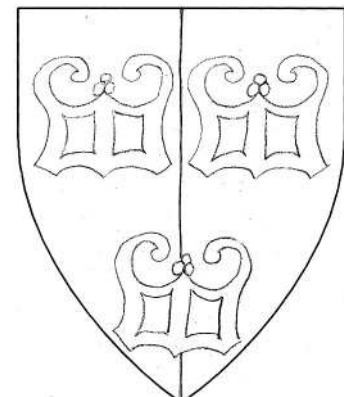
**Kara of Mountain's Keep.** Name and device. Per pale azure and argent, a horse rampant sable and in sinister chief a horseshoe azure within a bordure embattled sable. Unfortunately, the name must be returned because, while the submitter provided documentation for the given name with this submission, no documentation other than "household name" was provided for the byname as either a place name or a household name. Had she retained the byname *in stórráða* from her previous submission, the name could have been registered as Kára in stórráða with documentation entirely from *The Old Norse Name*. Alternatively, she could have used the name of the An Tir Shire of Fire Mountain Keep and made the name Kára of Fire Mountain Keep which would have been less authentic but still registerable. However, either of those changes seemed too great for us to make on her behalf. Even if the name had been acceptable, the device would have required radical redrawing for a more standard embattled bordure, a horse centered in the field and not overlain by the bordure (and with an eye!) and with a larger and more identifiable horseshoe that did not intersect with the bordure.



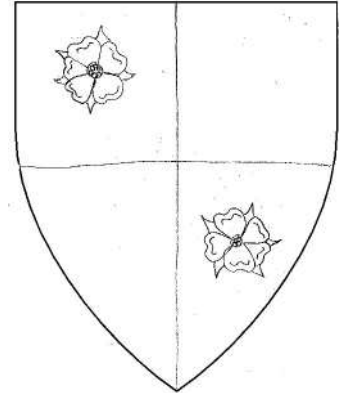
**Mungo Napier.** Device. Gules, a duck close contourny argent, billed and membered proper, on a chief argent three pheons inverted gules. Unfortunately, the identifying bill and feet in the colored emblazons are so red an orange on the emblazon sheets that they are virtual invisible against the gules and so this must be returned with a suggestion that the submitter allow a resubmission with the beak and feet Or which would have good contrast with the field.



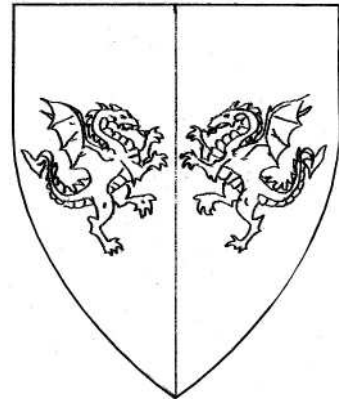
**Murienne l'aloiere.** Device. Per pale Or and gules, three furisons sable. Unfortunately, while a single sable furison could be placed on this divided field, commenters cited precedents that hold the furison that lies entirely on the gules portion of the field to violate our requirements for good contrast of all elements and so this must be returned



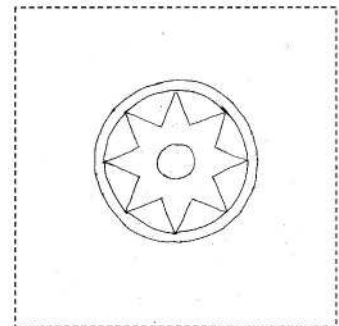
**Niese Keppel.** Device. Quarterly argent and purpure, two roses purpure barbed and seeded proper. Unfortunately, this must be returned for conflict with Maura MacDonald (“Per bend sinister Or and argent, in bend two roses purpure, triply leaved vert, seeded Or.”).



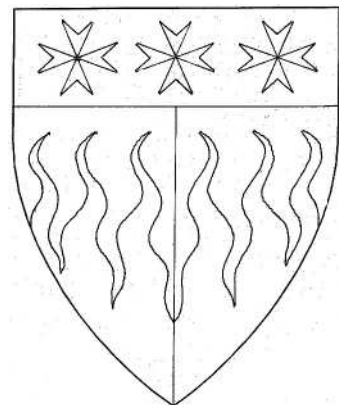
**Ormr Hjálmlólfsson.** Device. Per pale Or and azure, two dragons combatant counterchanged gules and argent. Unfortunately, this submission must be returned for conflict with Elerwyn Collyns (“Per pale argent and gules, two dragons combattant, each maintaining a halberd, counterchanged.”).



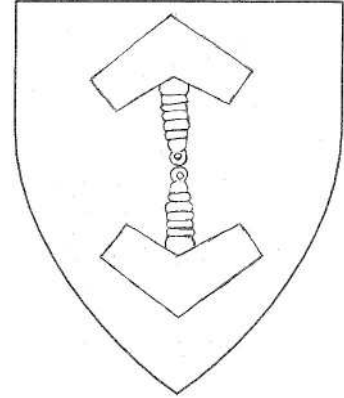
**Sean Mac Griogair.** Badge. (Fieldless) A mullet of eight points pierced within an conjoined to an annulet Or. Unfortunately, this badge must be returned for a technical (and possible visual) conflict with the badge of Walter de Witte (“Sable, a compass rose Or.”).



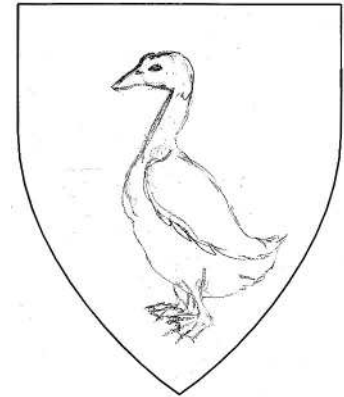
**Tancred of Messina.** Device. Per pale and per fess rayonny argent and gules counterchanged, on a chief sable three Maltese crosses argent. This must be returned for conflict with Sebastiano Francisco de Valencia (“Gyronny vert and argent, on a chief sable three Maltese crosses argent.”).



**Porgautr inn vikverski.** Device. Sable, in pale a Thor's hammer inverted and a Thor's hammer argent. This must be returned for conflict with the badge of Michael de Lynne ("Per pale sable and gules, in pale a Thor's hammer inverted and a Thor's hammer argent.").



**Vincent d'Orleans.** Device. Azure, a goose close Or. Unfortunately, thanks to a series of very specific Laurel precedents on the difference to be allowed for posture and type of marine birds, this must be returned for conflict with Gwineth McClelan ("Azure, a duck naiant between three roundels Or.") and Kirstan von Königsburg ("Azure, a swan naiant and in chief three mullets Or.").

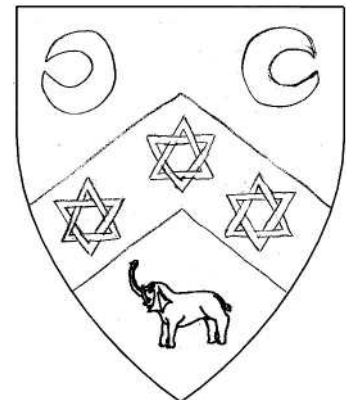


## PENDS

The following items have been pended for the stated reasons:

**Geoffrey Athos von Ulm.** Household name for the Company of the Lance of Saint George. While the name would work with no problems as an order name, a recent Laurel ruling returned "Company of the X Lance" as requiring different documentation from that for order names so this has been pended for further research and consultation with the submitter.

**Jamila bat Hayyīm.** Device. Purpure, on a chevron Or between an increscent, a decrescent and an elephant trumpeting argent three stars of David azure. Based on commentary we have pended this for redrawing with more standard crescents and perhaps a slightly larger elephant.



**Marinus, Barony of.** Guild name for Artisans of Fra Angelico. As commentary raised some doubts as to whether the artist was actually called *Fra Angelico* rather than *Frate Giovanni Angelico de Fiesole* in period and whether *Artisans* was a valid collective designator for a guild or other group, we have pended this for further research to document these forms.

**Sara Sinclair Napier.** Device. Azure, a duck naiant Or, billed proper, on a chief argent three pheons inverted azure. As the duck's orange bill lies against an azure field rather than the gules field of her husband's device, it has slightly better contrast and would probably be registerable. However, as she and her husband have expressed a strong desire for matching depictions of their armory, we have pended this to ascertain from her whether she wishes the bill to be recolored Or if her husband decides to do that for his device.
